ABSTRACT

M.A.& U.D.Deptt., - Water Supply - Revision of water charges for House Service Connections in respect of Urban Poor i.e., BPL House holds in the limits of all Urban Local Bodies - Orders - Issued.

ORDER:

In the G.O. Read above, orders were issued formulating a new strategy of the Urban Poor i.e., Below Poverty Line house holds, for provision of House Service connections as follows;

1. Any Below Poverty Line house hold, possessing a white ration Card and not having access to House Service Connection, shall be granted one HSC on payment of Rs.1200/- per connection including the cost of pipes and road cutting charges. The cost of the tap however, shall be borne by the individual.
2. In case of HMWSSB, the cost of road cutting charges being levied on the individuals, shall be borne by the respective ULBs.
3. The beneficiary shall be given the option of paying the amount in 12 equal monthly instalments without interest. The House Service Connection shall be given after payment of 1st installment and the rest shall be recovered along with the monthly/bimonthly billing for water consumed.
2. Government have decided to reduce the burden on the urban poor seeking tap connection and to make drinking water connections affordable to the BPL families, and decided to reduce the tap connection charges.
3. Government accordingly order that any Below Poverty Line house hold, possessing a white ration Card and not having access to House Service Connection, shall be granted one HSC on payment of Rs.200/- (Rupees Two Hundred only) per connection including the cost of pipes and road cutting charges, instead of Rs.1200/- as ordered in the G.O. Read above.
4. The orders issued in para 3 above shall be applicable to all Municipal Corporations and Municipalities in the State and shall come into force with immediate effect.
