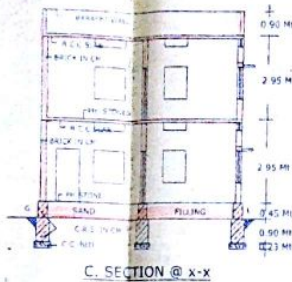
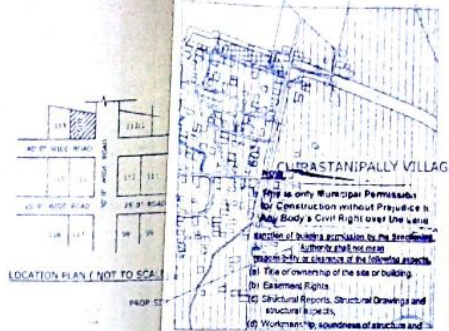


FRONT ELEVATION

LOCATION PLAN (NOT TO SCALE)



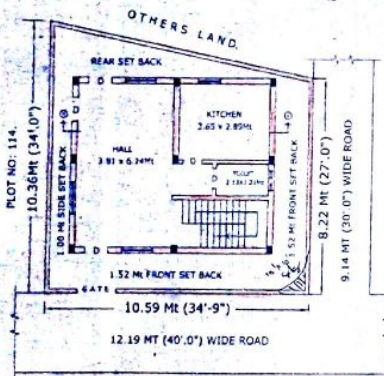

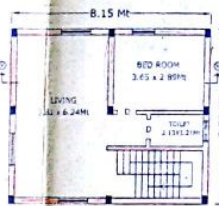

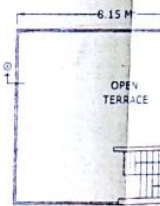
