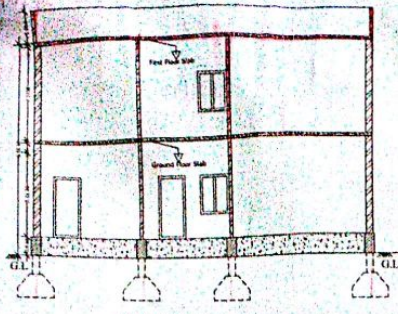


LOCATION PLAN

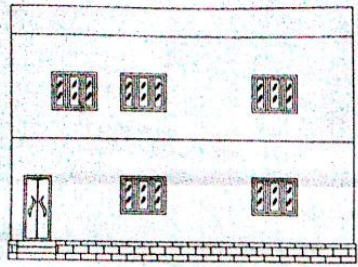

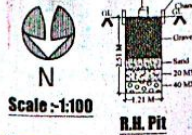

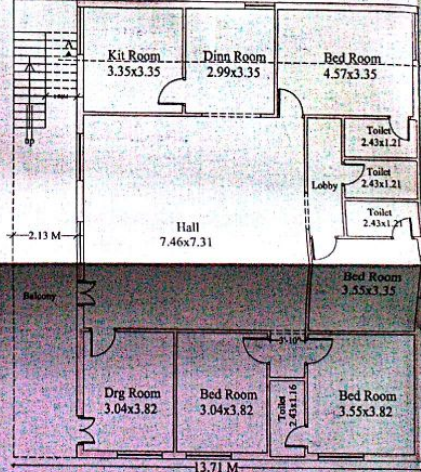

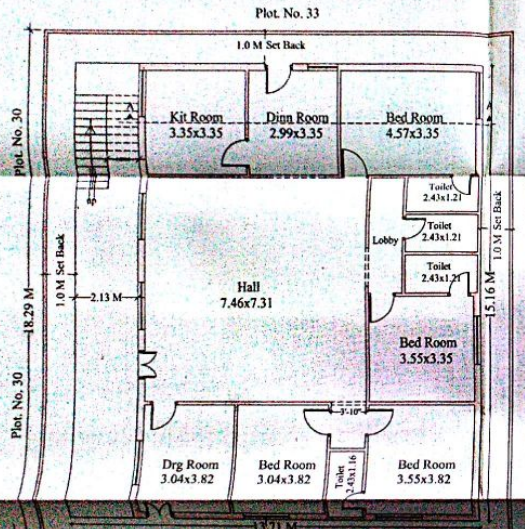

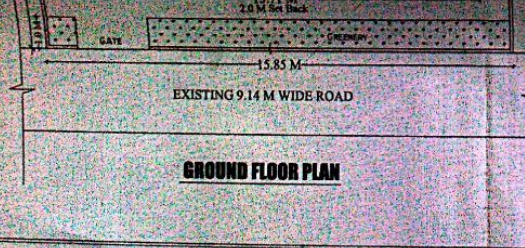
TERRACE FLOOR PLAN
