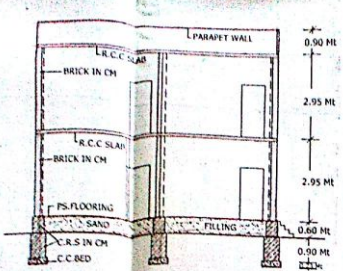
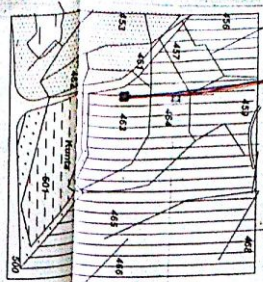


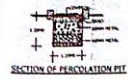
FRONT ELEVATION



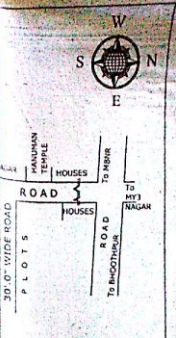
CROSS SECTION @ X - X



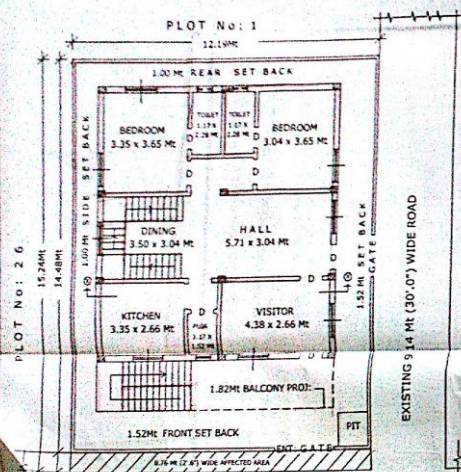

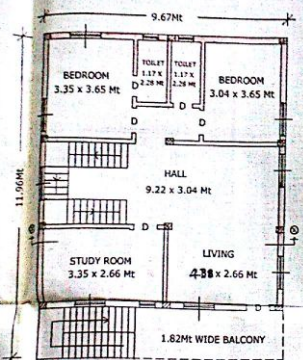
SECTION OF PERCOLATION PIT



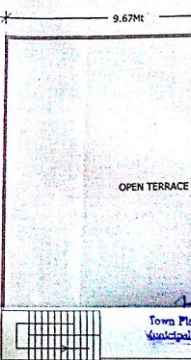
SITE PLAN ( NOT TO SCALE)
