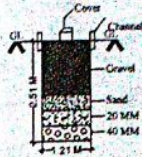

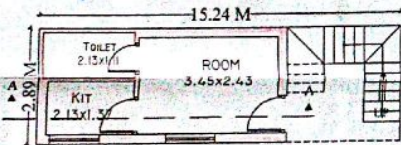
SITE PLAN



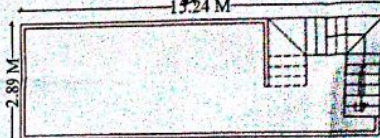

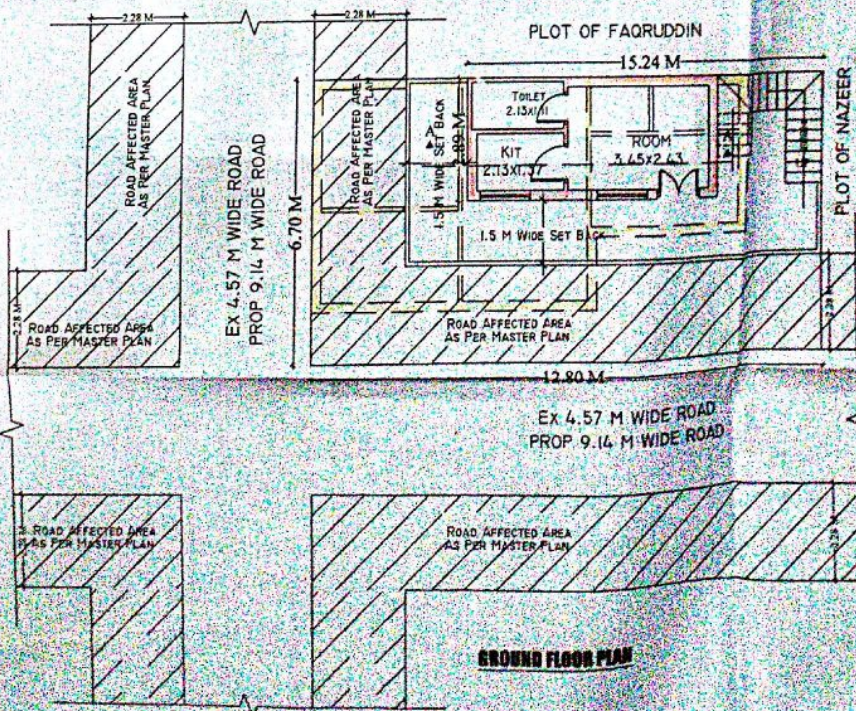
