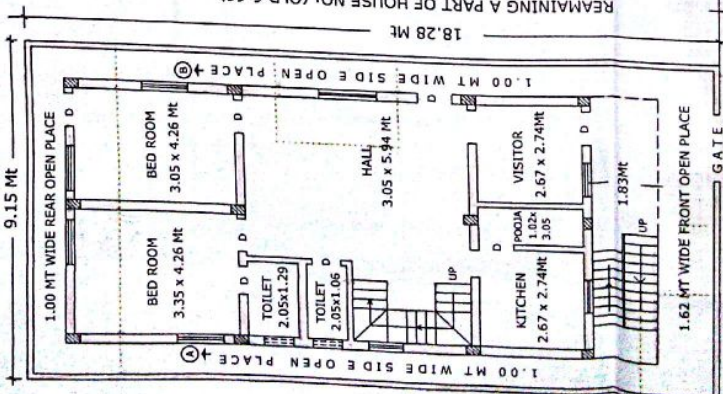


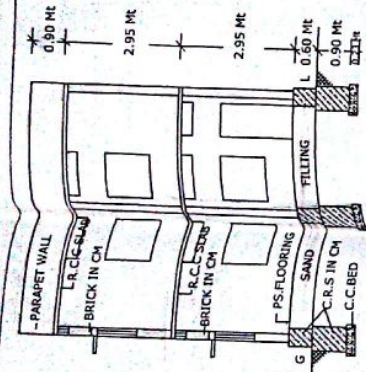
FRONT ELEVATION

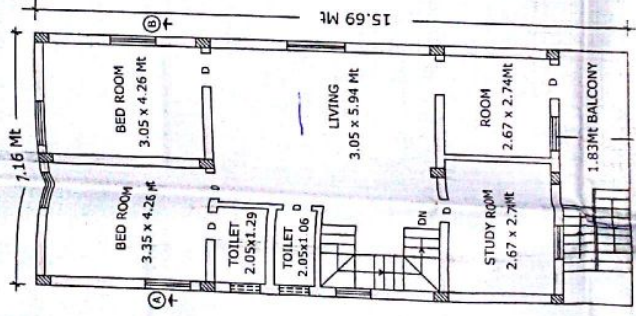


GROUND FLOOR PLAN

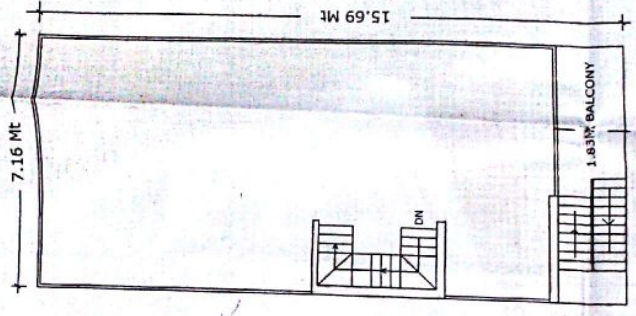
9.15 MT EXISTING WIDE ROAD



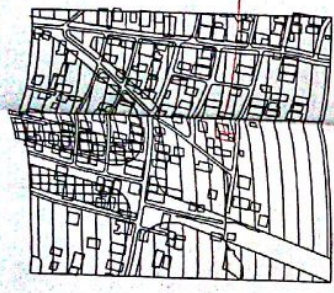
CROSS SECTION @ AB

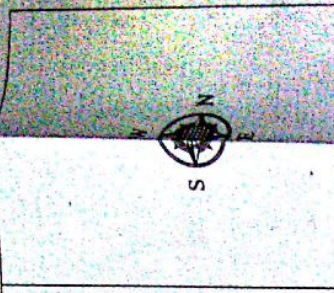
