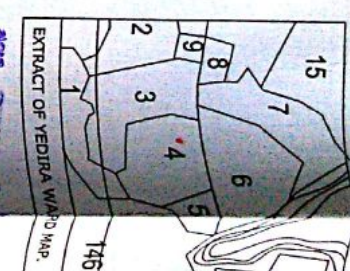


PLAN SHOWING THE PROPOSED CONSTRUCTION OF RESIDENTIAL BUILDING, GROUND FLOOR
