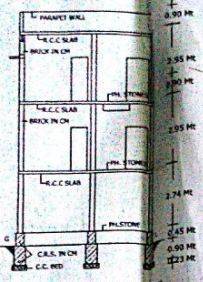
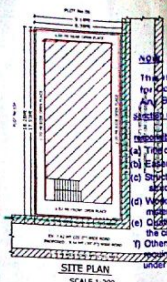


FRONT ELEVATION

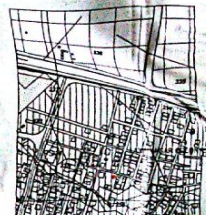


C. CROSS SECTION ON 'A-A'

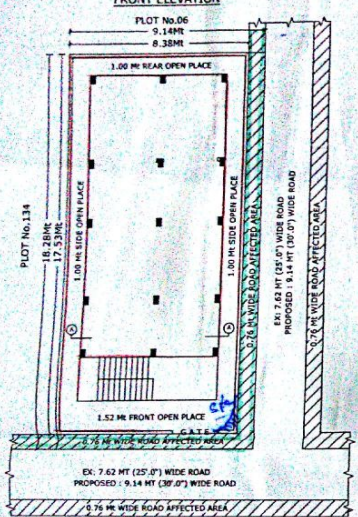

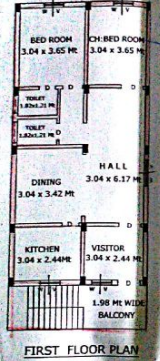

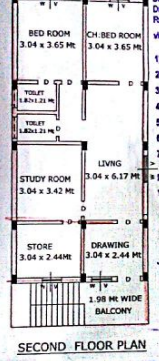

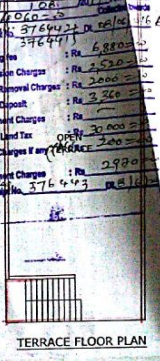
STILT FLOOR PLAN
