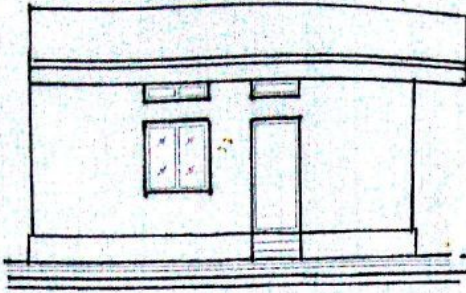
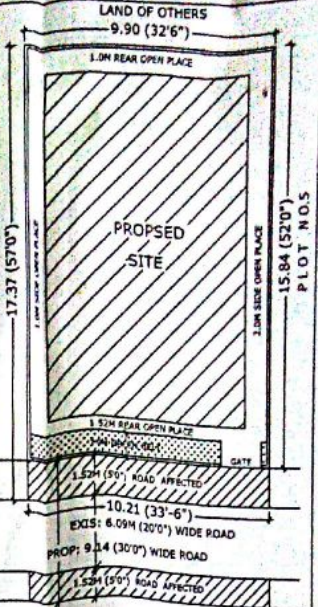
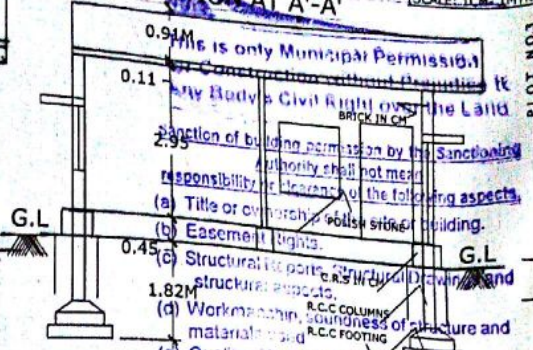


PLAN SHOWING THE PROPOSED HOUSE IN PLOT NO:4,

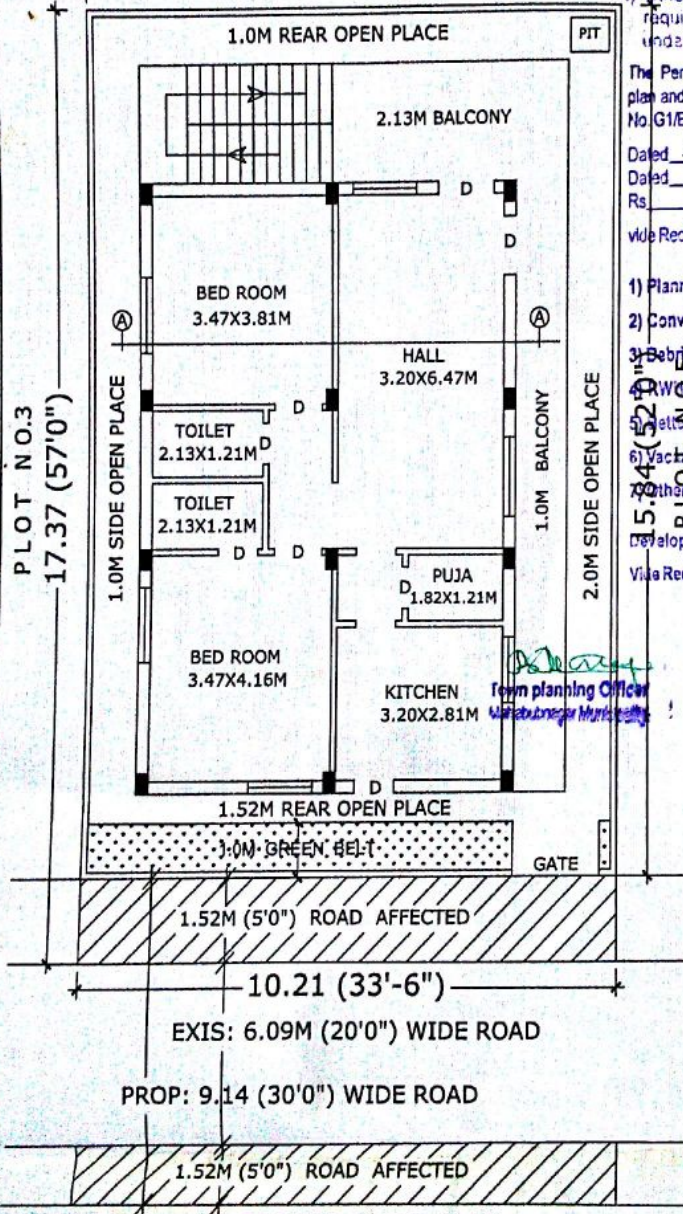

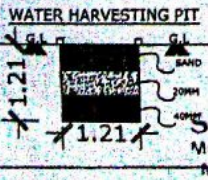
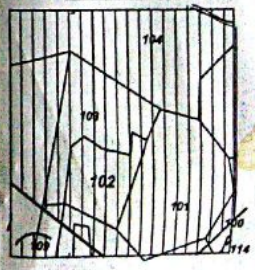
