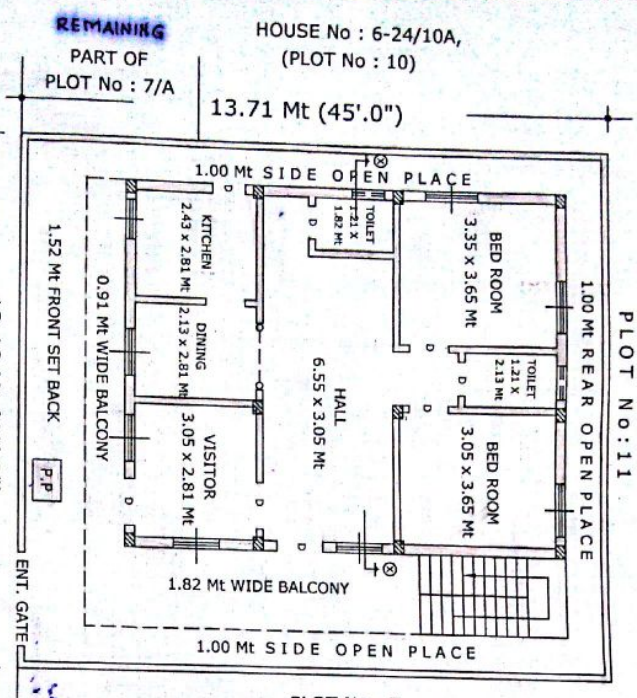

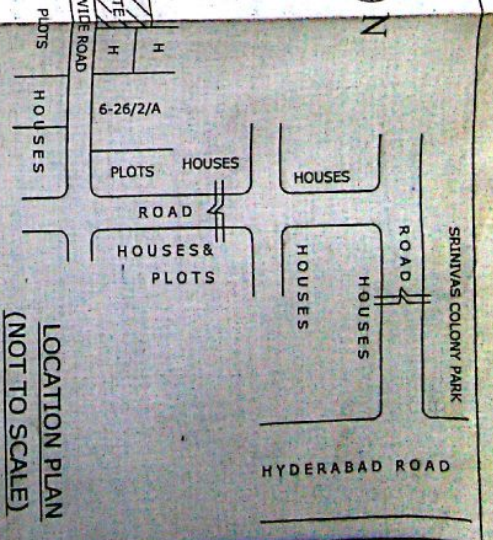
TERRACE FLOOR PLAN



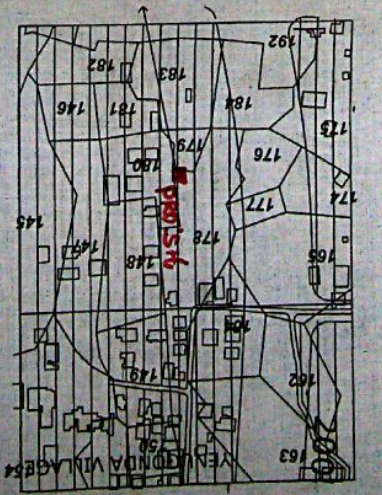
SECTION OF PERCOLATION PIT
