



Kindly peruse the Building application of Smt. Chintha Suvatha W/o. Sri Gandari Balraj in the open plot No.16 in Sy.No.274 & 336 of Waddegally(V) situated at Bhavani Nagar, Hanamkonda, Warangal Dist. for seeking permission for construction of A.C. sheet roofed room & Compound wall in an extent of Net Plot area 320.62 Sq.mts. In this connection, I have scrutinized & inspected the site and observed that, the proposed site is abutting to existing 36'-6" wide road on East, which is proposed as 40'-0" wide road, wherein the proposed site of an area 332.00 Sq.mts. is affecting 0.84 mts. depth to an extent of 11.38 Sq.mts. and the net plot area is 320.62 Sq.mts. for which the applicant has enclosed road affected area undertaking duly handing over at free of cost, but the proposed site is not covered by any approved Lay-Out & the applicant has not submitted LRS Proceedings.

Therefore, in view of the above reasons, the permission may be rejected and intimated the applicant accordingly and also directed the applicant not to commence the construction work in the site under reference until further orders.
