In this connection, I have scrutinized & inspected the site and observed that, the proposed site is abutting to existing 27'-0" wide road on West, which is proposed as 30'-0" wide road, wherein the proposed site of an area is 285.46 Sq.mts. is affecting 0.45 mts. depth to an extent of 4.96 Sq.mts. and the net plot area is 276.64 Sq.mts. for which the applicant has enclosed road affected area undertaking duly handing over at free of cost, but the proposed site is not covered by any approved Lay-Out & the applicant has not submitted LRS Proceedings.
