Kindly peruse the Building application of Sri. Avunoori Raju S/o. Sri Rajamallu in the open land in Sy.No.151 of Shayampet(V) situated at Hunter road, beside Rice Millar's Association building, Hanamkonda, Warangal Dist. for seeking permission for construction of Shops for Whole sale business Building in an extent of Net Plot area 218.13 Sq.mts. In this connection, I have scrutinized & inspected the site and observed that, the proposed site is abutting to existing 100'-0" wide road on North, which is proposed as 150'-0" wide B.T. road, wherein the proposed site of an area is 301.79 Sq.mts. is affecting 7.62 mts. depth to an extent of 83.66 Sq.mts. and the net plot area is 218.13 Sq.mts. for which the applicant has enclosed road affected area undertaking duly handing over at free of cost, but the proposed site is not covered by any approved Lay-Out & the applicant has not submitted LRS Proceedings.
