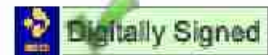

Kindly peruse the Building application of Smt. Kancharla Ashwini W/o. Sri. In this connection, I have scrutinized & inspected the site and observed that, the proposed site is abutting to 100'-0" wide road on East, which is proposed as 150'-0" wide road, wherein the proposed site of an area is 429.88 Sq.mts. is affecting 7.62 mts. depth to an extent of 77.83 Sq.mts. and the net plot area is 352.05 Sq.mts. for which the applicant has not enclosed road affected area undertaking and the proposed site is not covered by any approved Lay-Out & the applicant has not submitted LRS Proceedings.
