Nani Narender in the open plot No.78 in Sy.Nos.9, 11 & 12 of Gopalpur(V) in H.No.35-3-25/1/1/D situated at Gopalpur, Hanamkonda, Warangal Dist. for seeking permission for construction of G + (2) upper floors Residential Building in an extent of Net Plot area 298.00 Sq.mts.
